# COMPLY WITH EU PCN REGULATION BY 2025

#### Background

Hazardous mixtures that pose human health or physical hazards and are placed on the EU market must be notified to poison control centers. The aim is to provide the best possible medical advice to both individual consumers and health professionals in the event of exposure to hazardous mixtures.

To achieve this, the European Union decided to harmonise the information required to be provided to poison centers and its format by adopting a regulation in 2017. Regulation (EU) 2017/542 amends the CLP Regulation by adding Annex VIII.

Annex VIII of CLP requires companies to use a harmonised format for submitting information via a single portal managed by ECHA and to affix a UFI (Unique Formula Identifier ) on product labels. Notifications must be made according to a specific timetable and via the IUCLID 6 software.

#### What is UFI code?

Unique Formula Identifier (UFI) is a unique 16-character alphanumeric code that must appear on the label of your chemical products containing a mixture that is hazardous to human health or presents physical hazards. The purpose of the UFI code is to associate the chemicals placed on the market with the information you declare. All products labeled and notified with the same UFI must have the same composition.

#### **Timeline for Compliance**

**January 1, 2025:** Mandatory compliance begins; all hazardous mixtures (including those already placed on the EU market) must display UFI codes on labels.

From January 1, 2025: Enforcement starts, including inspections and penalties for non-compliance.

**2025 and Beyond:** Ongoing evaluations of UFI regulations may lead to further amendments. Businesses must remain vigilant and adapt to any changes.
